Notice to data subjects on personal data processing, based on Article 13 of the General Data Protection Regulation (GDPR)

PURCHASE OF A CAR PARK SEASON TICKET

- **Personal data filing system manager:**
 - Municipality of Ankarano, Jadranska cesta 66, 6280 Ankarano – Ancarano.
- **Contact details of the data protection officer (DPO), if appointed:**
 - DATAINFO.SI, poslovno svetovanje, založništvo in druge storitve d. o. o., Tržaška cesta 85, 2000 Maribor.
- **The purpose of personal data processing:**
 - Identifying and verifying the fulfilment of the conditions by persons wishing to conclude a contract for purchasing a car park season ticket, verifying the accuracy of the applicants' data, processing of applications for purchase, concluding a contract for the purchase of a car park season ticket, and managing data on active car park season ticket holders and car park season tickets issued.
- **The legal basis for personal data processing:**
 - Personal data processing is necessary for the implementation of a contract signed by the data subject to whom the personal data relates, or for the implementation of measures at the request of that data subject prior to the conclusion of the contract (Article 6 1(b) of the General Data Protection Regulation). In addition, Article 21a of the Local Self-Government Act provides that municipalities may obtain and process personal data for the purpose of exercising its powers and responsibilities, which, in this particular case, relate to the provision of the public service of "operation of designated public parking spaces".
- **Users or categories of personal data¹ users, if any:**
 - Municipality of Ankarano, Jadranska cesta 66, 6280 Ankarano – Ancarano.
- **Information on the transfer of personal data to a third country or international organisation:**
 - There is no transfer.
- **The period for which the personal data will be stored, or if that is not possible, the criteria used to determine that period:**

- When submitting an application for the purchase of a car park season ticket online, the copy of the vehicle registration certificate and the certificate of employment issued by the employer should be destroyed immediately after establishing the data subject's identity and verifying the accuracy of the data in the submitted application. Name and surname, e-mail address, telephone number, permanent residence address, temporary residence address, personal registration number, licence plate number, type of car park season ticket, and company name should be stored until the end of the contractual relationship, and then in accordance with the provisions of the Protection of Documents and Archives and Archival Institutions Act.
- **Information about the existence of a data subject's right to request from the controller access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability:**
 - Data subjects have the right to access, supplement, correct, restrict processing, delete and transfer personal data relating to them.
- **Information on the right to revoke consent when processing is based on consent:**

- **Information on the right to lodge a complaint with a supervisory authority:**

- **Information about whether**
 - the provision of personal data **is required by law or contract:** YES.
 - **the data subject to provide personal data** and the possible **consequences of failing to do so:** YES.
 - If the data subject fails to provide personal data required for appropriately establishing his or her identity and verifying the accuracy of data for issuing a car park season ticket, the contract cannot be concluded.
- **Information on the existence of automated decision-making, including profiling,** and, at least in those cases, meaningful information about **the logic** involved, as well as the **significance** and **the envisaged consequences** of such processing for the data subject.
